

St. Louis Area Rod Hundred Reliability Run

Tentatively planned to start somewhere in South St. Louis County with a destination / lunch stop in Fredericktown, MO. Details to follow, but total travel for this run will be 200 miles +/- round-trip. The homebound leg of the run will be less organized than the run down, so after lunch, folks can feel free to either continue, as a group making it a 2-lane round trip, or they can feel free to take the 4-lane, modern roads home without feeling that they have missed anything.

What is the Hot Rod Hundred?

The Hot Rod Hundred is designed to bring back something that has been missing**DRIVING!** The HRH is a 100+ mile long trek along the forgotten 2 lane highways. There will be places to stop for photos and to stretch out your legs and to swap stories, with the main destination being a lunch stop in Fredericktown, MO at Vance Vineyard and Winery Yeah, yeah, I know it has the same name as the organizer, so something sounds fishy and somebody will obviously be pocketing big bucks, right? **WRONG**, the fact is, it was chosen because there is a nice route to get to it, and I knew that I could impose on my uncle to host us as a group with as many or as few of us as there may be. (READ CAREFULLY BEFORE SIGNING)**

IN CONSIDERATION of being permitted to register and participate, compete, officiate, observe, work for, or be involved in any way in any CrossMembers Car Club [CMCC] events or activities (EVENTS),

I, for myself, my personal representatives, heirs and next of kin:

1. Hereby RELEASE, WAIVE, and DISCHARGE CMCC, individual club members, or any affiliate, subsidiary or subdivision thereof, event volunteers, promoters, participants, officials, car owners, drivers, rescue personnel, sponsors, advertisers, owners and lessees of premises used to conduct the EVENTS, premises and event inspectors, surveyors, underwriters, consultants and others who give recommendations, directions, or instructions or engage in risk evaluation or loss control activities regarding EVENTS and for each of them, their directors, officers, agents, and employees, all for the purposes herein referred to as "RELEASEES," FROM ALL LIABILITY TO ME, my personal representatives, assigns, heirs, and next of kin FOR ANY AND ALL LOSS OR DAMAGE, AND ANY CLAIM OR DEMANDS THEREFOR ON ACCOUNT OF INJURY TO THE PERSON OR PROPERTY OR RESULTING IN THE DEATH OF THE UNDERSIGNED ARISING OUT OF OR RELATED TO THE EVENTS, WHETHER CAUSED BY THE NEGLIGENCE OF THE RELEASEES OR OTHERWISE. In addition, I COVENANT NOT TO SUE any of the RELEASEES based upon any claim arising out of any of the EVENTS.
2. Hereby acknowledge that this is a driving event over public roadways. I take full responsibility for following all traffic laws of the state or local jurisdictional authority, and hereby take full financial responsibility for any liabilities that my arise as in connection with my participating vehicle(s).
3. Hereby ASSUME FULL RESPONSIBILITY FOR ANY RISK OF BODILY INJURY, DEATH OR PROPERTY DAMAGE arising out of or related to the EVENTS whether caused by the NEGLIGENCE OF RELEASEES or otherwise.
4. Hereby AGREE TO INDEMNIFY AND SAVE AND HOLD HARMLESS the RELEASEES and each of them from any loss, liability, damage, or cost they may incur due to claims brought against the RELEASEES arising out of my injury, or death, or damage to my property while I am participating in the EVENTS and/or while competing, practicing, officiating, observing or working for or for any purpose participating in the EVENTS and whether caused by the negligence of the RELEASEES or otherwise.
5. Hereby acknowledge that THE EVENTS ARE POTENTIALLY VERY DANGEROUS and involve the risk of serious injury and/or death and/or property damage. I also expressly acknowledge that INJURIES MAY BE COMPOUNDED OR INCREASED BY NEGLIGENT RESCUE OPERATIONS OR PROCEDURES OF THE RELEASEES.
6. Hereby agree that this Release and Waiver of Liability, Assumption of Risk and Indemnity Agreement extends to all acts of negligence by the RELEASEES, INCLUDING NEGLIGENT RESCUE OPERATIONS and is intended to be as broad and inclusive as is permitted by the laws of the Province or State in which the EVENTS are conducted and that if any portion thereof is held invalid, it is agreed that the balance shall, not withstanding, continue in full legal force and effect.
7. I grant to CMCC, its representatives and assigns the right to take photographs of me and my property in connection with the above-identified subject. I authorize CMCC, its assigns and transferees to copyright, use and publish the same in print and/or electronically. I agree that CMCC may use such photographs of me with or without my name and for any lawful purpose, including for example such purposes as publicity, illustration, advertising, and Web content.
